Eligibility: Competition (the "Florida Keys/Sea Angler holiday giveaway") is open only to legal residents of the United Kingdom and Ireland, who are at least twenty-one (21) years old at the time of entry. Employees of Monroe County, the Monroe County Tourist Development Council, Newman PR, Kelsey Media and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The "Florida Keys/Sea Angler holiday competition giveaway" is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Administrator's decisions, which are final and binding in all matters related to the "Florida Keys/Sea Angler holiday competition giveaway". How to Enter: During the Promotion Period, visit <u>www.seaangler.co.uk/win</u> and follow the instructions to complete and submit the entry form.

Drawing: The selection of a winner will be carried out by Kelsey Media and the selection of the potential winner is final and binding in all matters related to the competition. *Kelsey Media will randomly select the potential winner within 72 hours of the competition closing from all eligible entries received during the Promotion Period. The potential prize winner will be notified by email. If a potential winner cannot be contacted or fails to respond within 48 hours of the initial contact attempt, the potential winner forfeits the Prize. Except where prohibited, each potential prizewinner will be required to sign and return a Declaration of Compliance, Liability and Publicity Release*





("Declaration") which must be received by Kelsey Media, within seven (7) days of the date of the notice or attempted date of the notice when sent, in order to claim the prize. If a potential winner cannot be contacted or fails to return the Declaration within the required time period, the potential winner forfeits prize. The potential winner(s) must continue to comply with all terms and conditions of these Official Rules. Winning is contingent upon fulfilling all requirements.
